Taxes and Duties

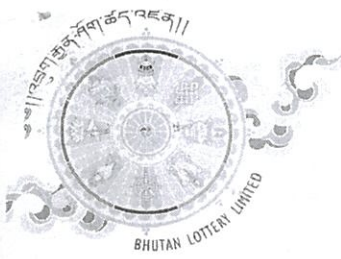
Prices
